- The Graphic Design Program offers Certificate and Associate level courses through onsite and online instruction.
- Students have the choice to earn the Certificate of Achievement, Associate of Applies
 Science Degree or the Associate of Arts Degree completely online.
- The Program prepares students for entry-level positions and provides students the opportunity to transfer with junior standing to a four-year college or university for a bachelor's degree within NSHE.
- AA Pathway has become the degree of choice over the AAS Degree.
- In 2019, WNC's Graphic Design Program ranked #4 in the Top 5 Online Associate in Multimedia Design programs in the U.S.
- In 2022, WNC's Graphic Design Program ranked #9 in the Best Online Graphic Design Certificate Programs in the U.S.
- In 2020, the Graphic Design Professor and advisor for the Graphic Design Program received the Nevada Board of Regents' Excellence in Teaching Award.

- In 2020, a WNC Graphic Design student designed a State of Nevada specialty license plate.
- Final Curriculum Review Report All requirements were met.
- A 5-year assessment plan was presented.
