Summary of Discussion: The meeting was called to order at 10:04am. Roll call was taken via the participation list. A quorum was present.

Agenda Item 2: Opening Remarks and College Updates - (Kyle Dalpe)

Action Taken: None

Summary of Discussion:

College Council is our formal governing body for decision making and a requirement for accreditation.

Tracking on enrollment basically flat to prior. Final numbers in December or January. Encouraged people to vote. Once we get through the election and see who is in key spots we then we can see what is going to happen at the state level. Lobbying for 12% reduction restoration and deferred maintenance.

Jim Strange – Question about legislative restoration of the 12%, what if it's 6% or 8%? what we are preparing for?

Impact of the budget cut is \$1.8M, \$1.3M is salaries or 17 positions. Executive team is looking at what if scenarios and can bring back to the group in December once we see who are in the seats. Projections will probably be run in January.

Summary of Discussion: Niki Gladys moved to approve the October 7, 2022 College Council minutes, Coral Lopez seconded the motion, the minutes were approved unanimously.

Agenda Item 4: PAT Division Name Change Update – Dana Ryan (Information Only) Action Taken: None

Summary of Discussion: A forum to talk about name change for Professional and Applied Technology division. Elevate understanding of what we do, both internally/externally what we do. 26 attendees most from PAT division giving input. Conversation between high school students and the college along with connectivity between community and college. Workforce, Career and Technical Education – WCTE is a recognizable name. The name change will be moving forward to Academic Affairs Council at board of regents meeting for next steps.

Agenda Item 5: RNL Student Satisfaction Inventory survey results – Cathy Fulkerson (Information Only)

Action Taken: None

Summary of Discussion: Last spring surveyed 1900 people, 18% response rate, students over the age of 18, no HEPP, Apprenticeship program, Dual Enrollment or Jump Start. 21% is a norm response rate. Women over responded students and 19-24 under responded compared to the population survey. Strengths ranked topics of importance, then ranked satisfaction. Green triangles are higher in satisfaction than with all community colleges participating. Cathy would like to talk with ASWN and Student Services. Safe and secure, well maintained, faculty are knowledgeable in their field, students made to feel welcome. Challenges, my program of study is providing me with the necessary preparation, quality of instruction used to be a strength and now is a challenge, in 2016 small amount of classes were held online and now 40% are online. First in importance to students is admissions and financial aid, second is safety and security, third is academic advising and counseling, forth is academic services, and fifth is instructional effectiveness.

Next steps for initiatives?

What most important things influencing students to enroll? Cost, financial aid, academic reputation, geographic setting, personalized attention prior to enrollment.

Students are trying to find their way in and how to make it work. If enrollment group could find areas to improve on and how we can advertise ourself to the community.

This spring we are participating in Community College Survey on Student Engagement
