The proposed Peace Officers Standards and Training (POST) Academy at Western Nevada College will be designed to meet or exceed current State of Nevada POST Academy training requirements as set forth by the Nevada Commission on Peace Officer Standards and Training. The program will also bring greater access to law enforcement training to rural agencies and counties within the WNC district.
