Health Documents

Measles/Mumps/Rubella (MMR) #1 – Required to enroll (see items 1, 3 below)	
Measles/Mumps/Rubella (MMR) #2 one month after #1 – Required to enroll	
Hepatitis B #1 (Hepb 1) – Required to enroll (see item 3 below)	
Hepatitis B #2 (Hepb 2) – one month after #1 - Required to enroll	
Hepatitis B #3 (Hepb 3) – 4-6 months after #1 - may be in progress	
PPD-TB (Tuberculosis Test) 1 st step – Required to enroll (see item 2 below)	
PPD-TB (Tuberculosis Test) 2 nd step – Required to enroll	
Tetanus (TDAP or DTAP preferred) -must be within 10 years	
Varicella (chickenpox) #1– Required to enroll (see item 3 below)	
Varicella (chickenpox) #2 – one month after #1– Required to enroll	
Influenza Vaccine: will be required by October 1 st for Fall Semester and Prior to enrollment of the Spring semester. (Not required for Summer)	
Covid 19 Immunization (Johnson & Johnson, Moderna, Pfizer)	
Major Medical Insurance-Required to enroll (see item 4 below)	
BLS (Basic Life Support-For Healthcare Provider) CPR Card: American Heart Association, Red Cross, Military Training Network, or Emergency Care and Safety Institute (CPRpro)– Required to enroll	
AEMT Certificate – must be registered with the <u>State of Nevada</u> as an Advanced Emergency Medical Technician within the last 2 years.	

Background Check Documents

Background check through mystudentcheck.com-ONLY required if a previous check for WNC is more than a year old. Select Background Check Only box in account options window. Results will be returned directly to the EMS/Paramedic Administrator. Due not later than day 5 of semester.

Drug Screen

Nine panel drug screen (yearly)-obtain form via email: ellie.dutton@wnc.edu Results will be returned directly to the Nursing & Allied Health office

1. MMR not required if born before January 1957. Titers are also accepted.
2. A two-step TB skin test is one test in each arm approximately 10 days apart; readings must be done 48-72 hours after the test in both cases. You may also submit two consecutive years of negative readings, no more than 52 weeks apart or a yearly Quantiferon blood test. PPD-TB skin tests must cover the duration of the course and must be updated annually.
3. Titers (blood draw) are also accepted for MMR, Hep B, and Varicella. If titer results are non-immune, a booster vaccine must be submitted after the titer date.
4. Short-term major medical insurance must cover the duration of the course.

Students must submit immunization, health insurance, etc. (Health) documents to the EMS/Paramedic Administrator for approval no later than 2 weeks prior to the semester. Students must register at mystudentcheck.com for their Background Check prior to submitting health documents. Any student becoming non-compliant with these requirements during the semester will not be permitted to participate in Labs or Clinicals.
